Mr. Warren holds a direct membership interest in Antero Investment and a direct membership interest in Antero Resources Employee Holdings LLC, a Delaware limited liability company, which holds a direct membership interest in Antero Investment. Mr. Warren may be deemed to have shared voting and dispositive power with respect to the 207,165,909 shares of Common Stock held directly by Antero Investment.

A family member of Mr. Warren directly owns 7 shares of Common Stock. Mr. Warren may be deemed to have shared voting and dispositive power with respect to the 7 shares of Common Stock held by such family member.

Mr. Warren expressly disclaims beneficial ownership with respect to all shares of Common Stock reported except to the extent of his pecuniary interest therein.
